# **COMMITTEE REPORTS**

<u>911</u> – Helicopter protocol- Complaint in Cass County caused restriction of out of state resources. The Sheriff and Dave worked very hard to gain 60 day stay and will continue to work to get the problem permanently fixed.

Dave has discussed the issues with the VHF system with Gabe from Telrad. Bad connections at the Bertrand Site were located. UPS was needed when dropping to the generator. The radios at Sumnerville were not wired into the generator properly. This will be corrected. All sites with get redundant UPS and generator back up. After complete tests can be performed gauge performance. The dispatchers are able to monitor the sites performance from the consoles. Discussion to install alarms was also discussed. Dave is also looking at the installation of a tone encoder which would allow us to monitor what the field units are hearing. Issues with Active 911 were identified and will be corrected.

High incident protocol was discussed. Dave has presented it to the 911 committees. Many issues and questions remain especially with LE. Dave intends to modify the plan and reissue to Chiefs. Committee was developed by Chief Davidson to work on and SOG for Area Command. (Lamb, Ruff, Brovold, Knisely, Connell)

<u>DNR</u> –Paul reported that there have not been a lot of Dune fires. One was caused by cottonwood material in electrical service. Allegan Art studio photos of smoke going through dune grass. Shore lines with critical Dune areas DNR have relaxed restriction on emergency access. Limited to emergency services. DOD equipment is available but

# Fire Chief I: Challenging Issues

This course addresses critical knowledge and skills pertaining to the responsibilities of a fire chief including such topics as local politics and the role of the chief officer, liability and risk management, resources and items of knowledge needed to become a first time leader in a new position in their agency.

# HIGH INCIDENT PROTOCOL (HIP)

Definition; events as described in the Berrien County Emergency Plan and/or any Homeland Security-National Incident Management System (NIMS)-TYPE 3 category; widespread and/or extended multiple-operational periods (i.e. severe storm, riot, active shooter, large fire, mass casualty incident, etc.), can overwhelm routine public safety response and communications practices, forcing public-safety to temporarily adapt to the situation in a manner that will streamline delivery of services under exigent circumstances. Even with additional personnel, the situation will require a higher level response and abbreviated communications processes to improve overall continuity of operations committed to the mitigation of threat/hazards in our communities, and enhance recovery efforts throughout the course of the event.

# A. HIP "Triggers"

Predictable Situations (communication outage, imminent severe weather warning, MABAS 3<sup>rd</sup> Alarm, Active Shooter w/multiple casualties); Dispatch would initiate HIP automatically as an established protocol for a given situation as described here.

<u>Evolved Situations</u> (communication system failure, weather event creating more widespread damage than predicted, disturbance growing into riot, etc.); Dispatch Supervisor recognizing dynamic unforeseen circumstances generating many more incoming calls, and/or higher amounts of resource mobilization than can be executed utilizing routine dispatch protocols.

# B. HIP Protocol Measures

Mobilize Extra Dispatch Staff – BCPSCC Supervisors/Shift Leaders are authorized to hold-over/call-in additional staff to manage communication volumes until assumed by EOC resources or normal service may be restored.

Notification - A countywide MPSCS broadcast and a Fire/EMS "ALL CALL-Civil Defense" paging will be executed, notifying core disciplines that HIP Protocol has been implemented due an exigent circumstance defined above. And specify, "EMD Emergency Rule is in effect, non-emergency Call Logging and LEIN Services are suspended, and all units and stations should prepare for direct dispatching and area commands."

EMD Emergency Rule – CFS volume often quickly exceeds the ability of dispatch personnel to manage them in a routine manner; Berrien Dispatch centers will invoke the 911 Medical "Emergency Rule," suspending medical post-dispatch and pre-arrival instructions that are not required for life-saving, and dispatch EMS resources without further documentation of response; units will track their own activity times.

Routine Call Logging Suspension - routine non-emergency logging/tracking of dispatches in the Computer Aided Dispatch (CAD) system will be suspended. Like the EMD Emergency Rule discussed above, once Dispatched to a non-emergency event, the BCPSCC will not be logging en-route and on-scene arrival times of specific units. However, related radio traffic should still be executed over designated radio channels to assure continuity of operations. As a result, CAD "Rip & Run" reports will not contain normal details. If necessary, specific data may be retrieved from the audio logger at a later time. High Incident-Calls for Service (CFS) will be tracked as such in the BCPSCC-CAD-Disposition Type section upon closing of the call.

LEIN Service Limitations – critical CFS volume will likely exceed the ability of dispatch personnel to manage them in a timely manner; BCPSCC supervisors have the discretion to temporarily re-assign the LEIN dispatcher position to assist with call-processing priorities. The BCPSCC will announce "Due to current emergency call load, Berrien Dispatch LEIN Services are suspended until further notice." Unless LEIN query assistance is critical, units must rely on their mobile-computer, seek queries from Niles Dispatch, or their local stations, until the call overload has been abated and Dispatch LEIN returned to service. A priority query should be requested directly from an area dispatcher (not LEIN).

C. Area Commands – initiated when either a majority of local public-safety resources are committed to a single dynamic incident (ex. active shooter, plane crash, large fire, etc.), or a wide-spread event affecting multiple and contiguous jurisdictions (ex. storm damage, haz-mat, etc.). Area Commands can operate either in conjunction with, or independent of an Incident Command that is already deployed to address a specific situation. The goal is to leverage available/remaining resources, and adjust regular mutual aid plans as necessary, through enhanced critical information sharing.

#### Area Command-Structures

Similar to Unified Command, the situation dictates which jurisdictional discipline will be the foundation for on-scene operations, however Area Commands also assume a more formal role in management of field units operating in their designated areas.

### SINGLE Jurisdiction Event

A single event has consumed multiple jurisdictional resources. Routine mutual aid/back-up practices for that region will require immediate adaptive review by area agencies, so they know what resources are still available to handle new call responses outside the event.

- 1. Law Enforcement may continue communicate on area MPSCS Talk-Groups.
  2. All Fire/EMS should be prepared to occupy their stations, either with an OIC or full staff according local protocol, to receive direct dispatching of calls in their area, directly over VHF BC2PAGE or 11F911. Upon receiving a call from Dispatch, area Stations with paging capabilities will dispatch their resources as needed over VHF BC2PAGE and "Active911 web-notification. Otherwise, the agency Commander may request Dispatch to execute the mobilization.
- WIDESPREAD Multi-Jurisdictional Event Once deployed, local Fire or Police Stations operating in the affected areas, will coordinate with each other in groups, assigned all UIC TG for a specific area of operation, to prioritize and directly mobilize (dispatch) their units/resources, to calls passed on to them by Dispatch or encountered by their own units as they respond to calls (area dispatch). Jurisdictions not necessary affected by the widespread event would still operate in the same manner as described in a Single Event (above), to alleviate critical dispatch information flow back-ups, and participating in high-level operations of affected Area Commands.

### D. Deactivation of HIP

HIP functions will be restored as practical, when agencies and Dispatch concur all are capable of executing the routine operation, by broadcasting over MPSCS/VHF.
