- Mobile CAD Committee formed at the 911 board meeting; Police Chief Association formed a committee as well. Requesting Fire Chiefs Association for a committee. All 3 committees will work together to get Mobile CAD up and running.

Policy committee:

- Incident Command video is up and running, linked on the BC Firefighter web page.
- BC Mutual Aid Agreement was discussed, with the added revisions below:
 - Key points Departments to follow Michigan PA 291 and MIOSHA part 74. Departments train on BCFCA IC and Mayday standards
 - Passport system to be used by all departments
 - o Departments must utilize 800 radio system
 - o Box Card up to the 5th alarm
 - Minimum staffing per apparatus was discussed, it was left as a "recommended 2 per apparatus no matter the apparatus".
 - Non-Certified responding to mutual aid calls What was discussed. It was left to the individual Chiefs to decide.
 - Helmet standard color system in place by January 1, 2026. To include
 - Chief officer White
 - Captains/LT Red
 - FF Black or Yellow
 - Cadets/EMS Blue
 - Non-certified designate with a green helmet front shield

BC Firefighter Association:

- Car show went well, they made about \$600.00 more than last year

- Smoke Detectors recommended getting on the State Program, Brian Kazmierzak is the "local dealer"
- Resource director is being updated, if anyone has updates, please get them to Gerry.
- The purchase of the cooler for the fair ground station was purchased. It was \$800.00 from both BC Chiefs and BC FF association.
- Meeting at the Fair Grounds August 7th, corn dogs, and elections will be held at the meeting.
- New Incident Command video is on the web page
- National night out is August 6th

Training:

- Fire 1&2 in Benton Harbor starting October 1st
- Water flow testing July 25th at Lake Twp Fire station

Other communication:

Communications Committee meeting update:

- Some departments still have too many auto aid requests on the initial alarm. Everyone felt that the box card workshop will help with that issue.
- Department Checking into service has not been tried. Going to leave the system in place.
- Expressed that every department needs to watch the communication video
- Dispatch will automatically be assigning an FG on structure fires
- IF a UIC channel is requested, dispatch advised that request should be honored
- Dispatch again asked that if you have an issue or questions, please contact the on-duty supervisor right away or email at 911supervisor@BerrienCounty.org
- It was determined at the MTG that the problem of radio communications will be reviewed by the committee to help departments. Issues with traffic will be sent to the department in question with a drafted letter and things to work on, along with an audio copy of the traffic.

- Radio IDs from Indiana, it was discussed and determined there are id's still
 available but it's not easy getting the radios programmed with the fees and
 location for adding them. It was brought up to work with Chad Hess at New
 Carlisle Fire and see who we write letters to expressing our concerns, from
 both Michigan and Indiana.
- Radio programming vouchers may be available by the end of July
